- Nomination papers may be only be delivered as follows:
 - Hand delivered only to Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN (Main Reception)
 - Please ask for a member of the Electoral Services Team on arrival
- Please note that nomination papers MUST be received within the statutory timescales at the location stated or they will not be accepted.
- If an election is contested the poll will take place on Thursday 19th September 2019.
- Applications for postal and postal proxy votes must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Wednesday 4th September 2019.
- Amendments or cancellations to existing postal, postal proxy and proxy votes must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Wednesday 4th September 2019.
- Applications to vote by proxy at this election must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Wednesday 11th September 2019.
- Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5pm on Wednesday 11th September 2019, must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Thursday 19th September 2019.
