THIS NOTICE is issued by the Council because it appears to them that there has 1. been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. THE LAND TO WHICH THE NOTICE RELATES

Land at Timberdale Guest House, Swindon Road, Wootton Bassett shown stippled on the attached plan.

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, change of use of the land from Guest house and dwelling to a mixed use for those purposes and as an electrical engineering business.

REASONS FOR ISSUING THIS NOTICE 4.

It appears to the Council that the above breach of planning control has occurred within the last ten years. Vehicles resulting from the unauthorised use turning off and entering this fast section of busy Class I road, at a point where visibility from and of such vehicles is restricted, are a source of danger and inconvenience to other road users, to the detriment of highway safety. The unauthorised use is contrary to Policy E12 of the North Wiltshire Local Plan and policy RE17 of the emerging North Wiltshire Local Plan.

5. WHAT YOU ARE REQUIRED TO DO

Stop using any part of the land as an electrical engineering business and remove from the land all plant, equipment and materials associated with that use.

6. TIME FOR COMPLIANCE

Twelve months after this notice takes effect.


YOUR RIGHT OF APPEAL

Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
