Without planning permission, change of use of the land from use for the storage of caravans to use for car sales and preparation of vehicles for sale, including the repair of vehicles.

4. REASONS FOR ISSUING THIS NOTICE

(i) It appears to the Council that the above breach of planning control has occurred within the last ten years. It is considered that use of land for vehicle preparation and car sales is inappropriate in an area of open countryside and at the side of a main traffic route into an historic settlement. 


