The listed building known as 25 High Street, Malmesbury, Wiltshire shown shaded on the attached plan ("the listed building").


#### SCHEDULE 2 - THE CONTRAVENTION

Unauthorised works to the listed building consisting of the installation of three upvc windows in the rear elevation.

#### SCHEDULE 3 - STEPS REQUIRED TO BE TAKEN TO REMEDY THE BREACH

- a) Remove the upvc windows in the rear elevation marked A, B and C on the attached sketch.
- b) Install traditionally detailed painted timber sash windows in place of the upvc windows, rebated and recessed back from the face of the wall as at 27 High Street, using traditional sash weights with single glazing.
- c) The timber sash windows in the openings marked A and B on the attached sketch shall be an exact replica of the sliding timber sash window marked 1 in the rear elevation of 27 High Street
- d) The timber sash window in the opening marked C on the attached sketch shall be an exact replica of the sliding timber sash window marked 3 in the rear elevation of 27 High Street.




