## **ENFORCEMENT NOTICE**

ISSUED BY: North Wiltshire District Council

1. THIS NOTICE is issued by the Council because it appears to them that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

### 2. THE LAND TO WHICH THE NOTICE RELATES

Land and Building at 11 The Bridge, Chippenham, Wiltshire SN15 1HA shown hatched on the attached plan.

# 3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, the carrying out of alterations that materially affect the external appearance of the elevation of the building facing The Bridge, Chippenham.

#### 4. REASONS FOR ISSUING THIS NOTICE

- a) It appears to the Council that the above breach of planning control has occurred within the last four years.
- b) The building is situated within the Chippenham Conservation Area and the alterations are unsympathetic to the architectural character of the building and the area contrary to Policy RB3 of the North Wiltshire Local Plan and Policy HE7 of the Wiltshire Structure Plan 2011.
- c) The alterations do not respect the character and appearance of the subject building or pay regard to its style, scale, proportions and

architectural details contrary to Policy RS10 of the North Wiltshire Local Plan 2001

### 5. WHAT YOU ARE REQUIRED TO DO

Replace the existing ground floor exterior frontage with the new shop front granted permission under Council's reference 03/00983/FUL on 14 July 2003 detailed in Drawing No. 1185/10A attached to this notice.

### 6. TIME FOR COMPLIANCE

Six months from the date this notice takes effect.

### 7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 24 December 2004 unless an appeal is made against it beforehand.


### YOUR RIGHT OF APPEAL

The enclosed booklet "Enforcement Notice Appeals - A Guide to Procedure" sets out your rights. You may use the enclosed appeal forms.

- (a) One is for you to send to the Secretary of State if you decide to appeal, together with a copy of this enforcement notice.
- (b) The second copy of the appeal form should be sent to the Council.
- (c) The third copy is for your own records.

#### WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on the date specified in paragraph 7 of the notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period specified in paragraph 6 of the notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
