

**TOWN AND COUNTRY PLANNING ACT 1990
(as amended by the Planning and Compensation Act 1991)**

ENFORCEMENT NOTICE

ISSUED BY: North Wiltshire District Council

1. **THIS NOTICE** is issued by the Council because it appears to them that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land The Meadows, Brinkworth Road, Wootton Bassett, Swindon, SN4 8DT
shown hatched on the attached plan.

3. **THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF
PLANNING CONTROL**

Without planning permission, the change of use of land and buildings from use as a single dwellinghouse (Class C3 of the Town and Country Planning (Use Classes) Order 1987) to a use for that purpose and the addition of a separate self contained unit of residential accommodation.

4. **REASONS FOR ISSUING THIS NOTICE**

- a) It appears to the Council that the above breach of planning control has occurred within the last ten years.
- b) The unauthorised development results in the creation of a separate dwelling unit outside the framework boundary and the physical limits of a settlement where new dwellings, under Policy RH11 of the North Wiltshire Local Plan, will not be permitted unless connected with the essential needs of agriculture or forestry. The development is also contrary to Policies C3 and H4 of the North Wiltshire Local Plan 2011 Revised Deposit Draft and the Government's aims of sustainable development

reducing the need for the use of the private car contained in PPG 13 Transport.

- c) The establishment of an additional separate dwelling unit on this site is likely to lead, in due course, to additional development by way of extensions or redevelopment, which the Council would find difficult to resist but would further erode the character of the countryside in the area contrary to Policy RC9 of the North Wiltshire Local Plan and Policies C3 and NE15 of the North Wiltshire Local Plan 2011 Revised Deposit Draft.

5. WHAT YOU ARE REQUIRED TO DO

- a) Cease the use of the land and buildings as two separate units of residential accommodation.
- b) Restore the land and buildings to a single dwellinghouse (Class C3 of the Town and Country Planning (use Classes) Order 1987)

6. TIME FOR COMPLIANCE

Six months from the date this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 11 April 2005 unless an appeal is made against it beforehand.

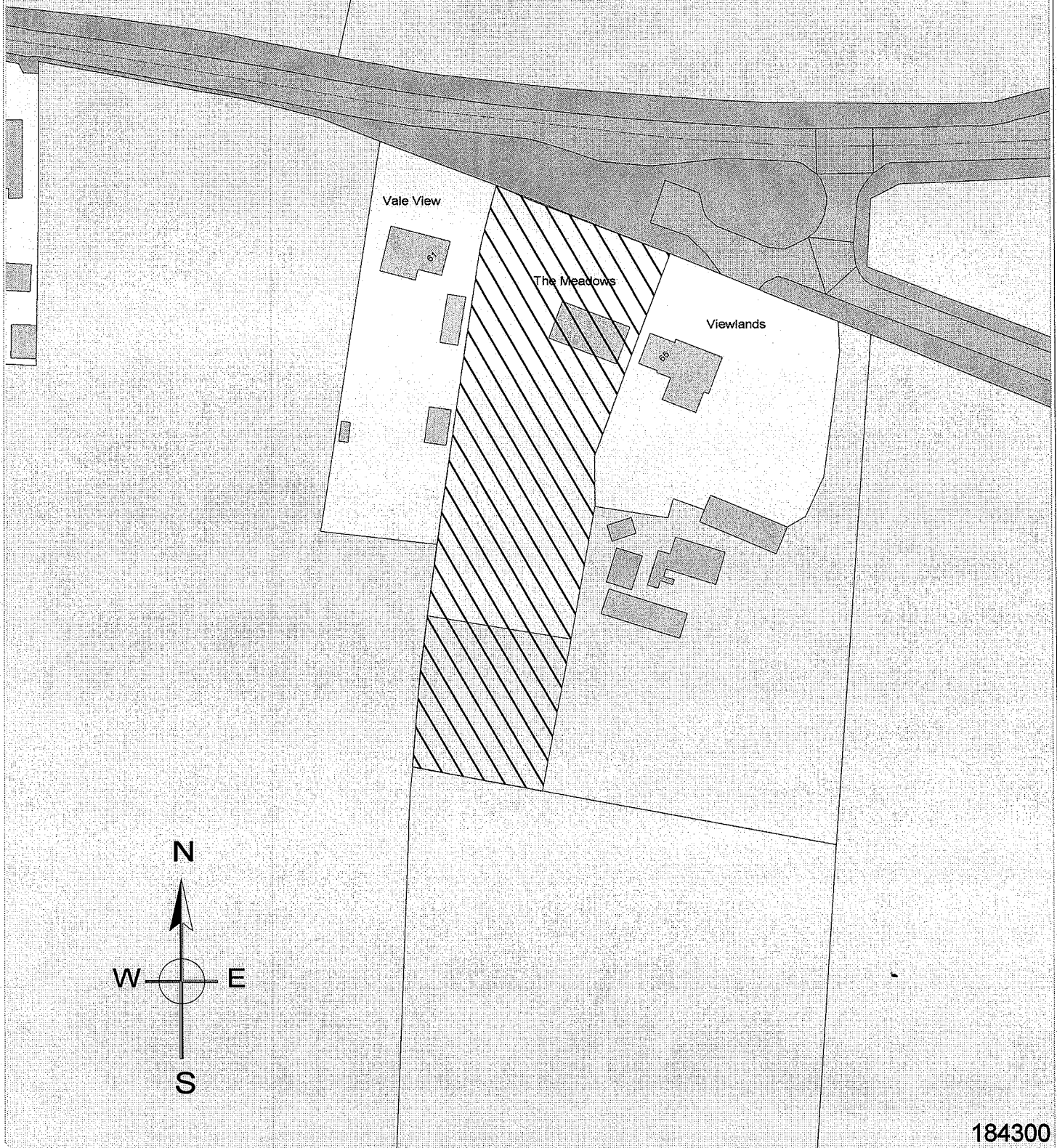
- (a) One is for you to send to the Secretary of State if you decide to appeal, together with a copy of this enforcement notice.
- (b) The second copy of the appeal form should be sent to the Council.
- (c) The third copy is for your own records.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on the date specified in paragraph 7 of the notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period specified in paragraph 6 of the notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
