3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, the change of use of the land from Class C3 (Dwellinghouse) to a mixed use of Class C3 (Dwellinghouse) and the operation of a car hire business.

4. REASONS FOR ISSUING THIS NOTICE

- a) It appears to the Council that the above breach of planning control has occurred within the last ten years.
- b) The continued use of this land without planning permission for business purposes would, in due course, lead to the unauthorised development becoming lawful. The unrestricted use of this land in association with a car hire business would have adverse effects upon the amenity enjoyed by the occupiers of nearby residential properties.
- c) The land is situated in a residential area where any commercial uses other than small scale business uses generating very few vehicle

movements and no personal callers, with limited activity at the premises, would be seriously detrimental to the amenity enjoyed by occupiers of nearby residential properties.

5. WHAT YOU ARE REQUIRED TO DO

- a) Cease using the land for the operation of a car hire business providing more than two cars for hire.
- b) Cease using the land for the parking, maintenance, cleaning, polishing or storage of more than two cars used for the purposes of hire, whether or not with a driver.
- c) At no time shall any customers or potential customers for hiring the cars visit the premises either to inspect cars or to start or finish a journey or for any other purpose in connection with a car hire business

6. TIME FOR COMPLIANCE

Two months from the date this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 17 August 2004 unless an appeal is made against it beforehand.




