ENFORCEMENT NOTICE

ISSUED BY: North Wiltshire District Council

1. THIS NOTICE is issued by the Council because it appears to them that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. THE LAND TO WHICH THE NOTICE RELATES

Land to the south of 1 Pretty Chimneys, Kington Langley, Chippenham, Wiltshire, SN14 6BH shown hatched on the attached plan ("the site").

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, the change of use of land from agriculture to use for motorcycle activities not associated with agricultural use and the positioning of a storage container.

4. REASONS FOR ISSUING THIS NOTICE

- a) It appears to the Council that the above breach of planning control has occurred within the last ten years.
- b) By reason of its proximity to residential properties, the use of the land by motorcycles results in an unreasonable disturbance to the amenities of local residents. Also due to the site's prominent rural location its use for motorcycle activities is detrimental to the rural character and amenity of the area. The development is therefore contrary to the provisions of policy RC9 of the adopted North Wiltshire Local Plan 2001 and Policy C3 of the North Wiltshire Local Plan 2011 revised deposit draft.

c) The continued use of this land by motorcycles without planning permission would, in due course, lead to the unauthorised development becoming lawful. The loss of planning control over the use of this land by motorcycles could lead to further intensification of the use to the detriment of the rural character and amenity of the area.

5. WHAT YOU ARE REQUIRED TO DO

- a) Cease the use of the land by motorcycles that are not used incidental to the use of the land for agricultural purposes.
- b) Remove from the land the storage container currently located within the south eastern corner of the car park and marked diagrammatically with an "X" on the attached plan
- c) Remove from the land the wall of straw bales not used for agricultural purposes, located at the northern end of the site adjacent to the car park and marked diagrammatically with a heavy black line on the attached plan.

6. TIME FOR COMPLIANCE

One month from the date this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 12 May 2005 unless an appeal is made against it beforehand.



3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, the carrying out of engineering operations by the laying out of a motorcycle track and re-contouring of the land to create mounds and depressions for use in connection with motorcycle activities.

4. REASONS FOR ISSUING THIS NOTICE

- a) It appears to the Council that the above breach of planning control has occurred within the last four years.
- b) By reason of its proximity to residential properties, the use of the land by motorcycles results in an unreasonable disturbance to the amenities of local residents. Also due to the site's prominent rural location its use for motorcycle activities is detrimental to the rural character and amenity of the area. The development is therefore contrary to the provisions of policy RC9 of the adopted North Wiltshire Local Plan 2001 and Policy C3 of the North Wiltshire Local Plan 2011 revised deposit draft.

5. WHAT YOU ARE REQUIRED TO DO

- a) Restore the site levels in accordance with the natural contours of the land over the whole of the site by the removal of all mounds, bunds and other areas where material rises above natural ground level and filling of all depressions below natural ground level with soil.
- c) Finish the surface of the land where it has been disturbed by the need to comply with the requirements in paragraphs 5a) of this notice with topsoil to a depth of at least 75mm.
- d) Sow grass seed over the whole of the restored areas.

6. TIME FOR COMPLIANCE

Four months from the date this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 12 May 2005 unless an appeal is made against it beforehand.


