3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, the change of use of land from a mixed use for agriculture and the keeping of horses to a mixed use for that purpose and for use by a fencing and building contractor for workshop and storage purposes.

4. REASONS FOR ISSUING THIS NOTICE

- a) It appears to the Council that the above breach of planning control has occurred within the last ten years.
- b) The site is situated in the open countryside and the unauthorised use is detrimental to the character of the area in particular and rural amenity in general, and if allowed would set a precedent for further undesirable development on this site contrary to Policies RE19 and RC9 of the North Wiltshire Local Plan.
- c) Should the Council take no enforcement action against this unauthorised use it would become lawful. The continued use of this site for an

inappropriate use without any restrictions and involving open storage and activities may encourage the use to intensify to the further detriment of the countryside.

5. WHAT YOU ARE REQUIRED TO DO

- a) Cease using the land for workshop and storage purposes not associated with agriculture and/or the keeping of horses.
- b) Remove all materials, tools, generators, mixers and other items associated with the unauthorised use, and any debris, from the site.

6. TIME FOR COMPLIANCE

Four months from the date this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 3 August 2005 unless an appeal is made against it beforehand.




