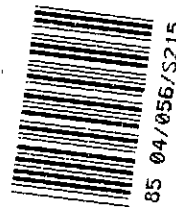

1. THE NOTICE

This Notice is served by the Council under Section 215 of the above Act because it appears to them that the amenity of a part of their area is adversely affected by the condition of the land described below.

2. THE LAND TO WHICH THIS NOTICE RELATES

The land known as OS0700, Ramps Hill, Braydonside, Brinkworth, Chippenham, Wilts SN15 5AR shown hatched on the plan attached to this Notice ("the Land").

3. WHAT YOU ARE REQUIRED TO DO

Remove the caravan, all trailers, the fuel storage container, the green storage container, the red van, all wooden pallets, all Herras fencing, all oil drums, the horse box, all steel girders, sheeting and all other items from the Land.

4. TIME FOR COMPLIANCE

Within a period of two months from the date this Notices takes effect.

5. WHEN THIS NOTICE TAKES EFFECT.

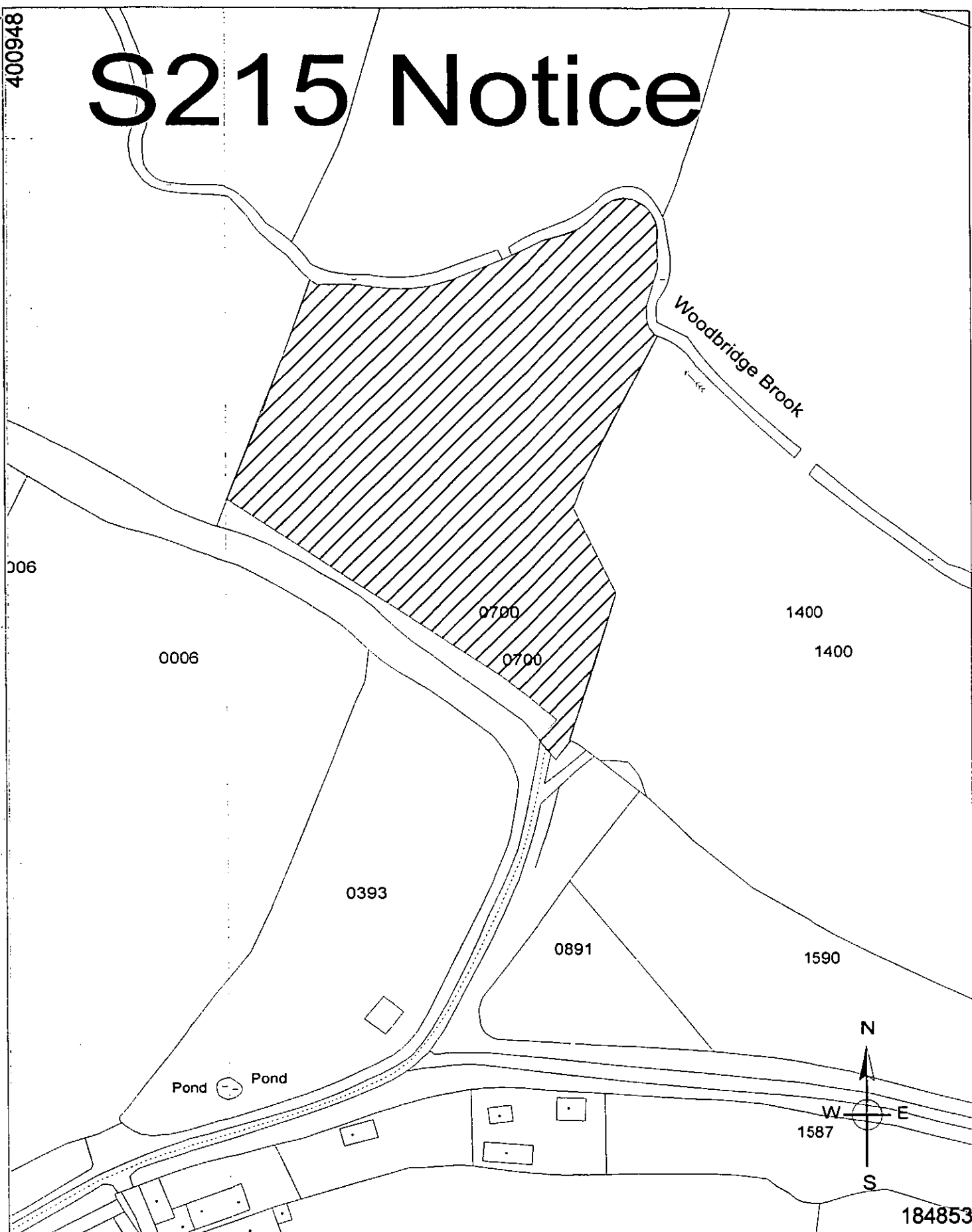

TOWN AND COUNTY PLANNING ACT 1990 - SECTION 215 NOTICE

Land at Ramps Hill, Braydonside, Brinkworth, Wiltshire

The Council has issued a Notice under Section 215 of the above Act and I now serve on you a copy of that Notice, in view of your interest in the Land. Unless an appeal is made in the manner described below, the Notice will take effect on the date shown on the Notice and you must then ensure that the required steps are taken within the period or periods specified in the Notice. If you fail to take the steps required by the Notice, within the time specified for compliance (or such period as the Council will allow), you will be guilty of an offence and liable on summary conviction to a fine not exceeding level 3 on the standard scale (currently £1,000).

If you wish to appeal against the Notice, you should make your appeal to the Clerk to the Justices, The Courthouse, Pewsham Way, Chippenham, SN15 3BF. Any appeal must be made before the date the Notice comes into effect.
