ENFORCEMENT NOTICE AT LAND AT 1 SPIRES VIEW, PEWSHAM, CHIPPENHAM, WILTSHIRE

TOWN AND COUNTRY PLANNING ACT 1990 (as amended by the Planning and Compensation Act 1991)

ENFORCEMENT NOTICE

ISSUED BY: North Wiltshire District Council

1. **THIS NOTICE** is issued by the Council because it appears to them that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. THE LAND TO WHICH THE NOTICE RELATES

Land at 1 Spires View, Pewsham, Wiltshire, shown hatched on the attached plan ("the Land").

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, the material change of use of 'the Land', to a use for the siting and occupation of a residential caravan /static mobile home.

4. REASONS FOR ISSUING THIS NOTICE

- a) It appears to the Council that the above breach of planning control has occurred within the last ten years.
- b) The proposed residential caravan/ mobile home would be sited in open countryside outside the framework of a settlement which would be detrimental to the character of this area, in particular, and rural amenity in general and would be contrary to Policy H4 and NE15 of the North Wiltshire Local Plan (2011).

ANNEX

YOUR RIGHT OF APPEAL

You can appeal against this notice, but any appeal must be received, or posted in time to be **received**, by the Secretary of State **before** the date specified in paragraph 7 of the notice. The enclosed booklet "Enforcement Notice Appeals - A Guide to Procedure" sets out your rights. You may use the enclosed appeal forms.

- (a) One is for you to send to the Secretary of State if you decide to appeal, together with a copy of this enforcement notice.
- (b) The second copy of the appeal form should be sent to the Council.
- (c) The third copy is for your own records.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on the date specified in paragraph 7 of the notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period specified in paragraph 6 of the notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.

- c) The proposed residential caravan/ mobile home, by reason of its sitting, would have a detrimental impact on the amenities of the adjoining occupiers. The proposal would therefore be contrary to Policy C3 of the North Wiltshire Local Plan (2011).
- d) The continued use of 'the Land', without planning permission, for the stationing and occupation of a caravan/ mobile home would, in due course, lead to the unauthorised development becoming lawful.

5. WHAT YOU ARE REQUIRED TO DO

a) Cease the residential use of the caravan/ mobile home.

6. TIME FOR COMPLIANCE

Three months from the date this Notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT


This notice takes effect on 2nd April 2008 unless an appeal is made against it beforehand.
