#### 4. THE BREACH OF CONDITION.

The following condition has not been complied with:

Condition 3: No machinery shall be operated, no industrial process shall be carried out on site before 08:00 hours on weekdays and Saturdays nor after 18:00 hours on weekdays and 13:00 hours on Saturdays, nor at any time on Sundays, Bank or Public Holidays. There shall be no deliveries received or goods despatched from the site before 08:00 hours on weekdays and Saturdays nor after 17:30 hours on weekdays and Saturdays, nor before 10:00 hours and after 16:00 hours on Sundays, Bank or Public Holidays.

Reason: In the interests of the amenity of the area.

#### 5. WHAT YOU ARE REQUIRED TO DO

1) Ensure that no machinery is operated and no industrial process carried out on site before 08:00 hours on weekdays and Saturdays nor after 18:00 hours on weekdays and 13:00 hours on Saturdays, nor at any time on Sundays, Bank or Public Holidays. Ensure that no deliveries are received or goods despatched from the site before 08:00 hours on weekdays and Saturdays nor after 17:30 hours on weekdays and Saturdays, nor before 10:00 hours and after 16:00 hours on Sundays, Bank or Public Holidays.

#### 6. PERIOD FOR COMPLIANCE

1 month from the date this Notice is served on you.
