

WHEREAS:

- It appears to the North Wiltshire District Council ("the Council") being the local planning authority for the purposes of Section 87 of the Town and Country Planning Act 1971 ("the Act") in this matter, that there has been a breach of planning control within a period of four years before the issue of this notice on the land or premises ("the land") described in Schedule 1 below.
2. The breach of planning control which appears to have taken place consists of the failure to comply with the condition set out in schedule 2A below relating to the building of a new dwelling and subject to which planning permission was granted on the 16th October, 1978 for the development of that land, in the respect set out in schedule 2B below.
 3. The Council consider it expedient, having regard to the provisions of the development plan and to all other material considerations, to issue this enforcement notice, in exercise of their powers contained in the said section 87 for the reasons set out in the annex to this notice.

NOTICE IS HEREBY GIVEN that the Council require that the steps specified in Schedule 3 below be taken in order to remedy the breach within the period of one month from the date on which this notice takes effect

THIS NOTICE SHALL TAKE EFFECT, subject to the provisions of section 88(10) of the Act, on 1st April, 1982.
