

Reason for Issue :-

1. 8.0. 12

- 1. The development, by virtue of the scale and design of the building and the nature of the use, is contrary to Policy Ell of the North East Wiltshire Structure Plan, which states that in the countryside the change of use of buildings to use for employment purposes will normally be permitted only where access and services are satisfactory, the scale and design of the buildings are compatible with the local environment and where the proposal will not detract from the amenities of the locality and the character of the countryside.
- 2. The present use of the building and the associated land is, by reason of noise and visual intrusion, damaging to the amenity which can reasonably be expected in this location.

ENFORCEMENT NOTICE

WHEREAS :

- (1) It appears to the North Wiltshire District Council ("the Council") being the local planning authority for the purposes of Section 87 of the Town and Country Planning Act 1971 ("the Act") in this matter, that there has been a breach of planning control after the end of 1963 on the land or premises ("the land") described in Schedule 1 below.
- (2) The breach of planning control which appears to have taken place consists in the carrying out of development by the making of the material change in the use of the land described in Schedule 2 below, without the grant of planning permission required for that development.
- (3) The Council consider it expedient, having regard to the provisions of the development plan and to all other material considerations, to issue this enforcement notice, in exercise of their powers contained in the said Section 87, for the reasons set out in the ANNEX to this Notice.
