





Reasons for Issue:-

1. The use results in a visually incongruous and prominent element within a residential area that harms the character appearance and amenities of the locality.
2. The introduction of an industrial or commercial use into a residential area by reason of the activities involved, the visual intrusion and the associated traffic movements, seriously harms the amenity reasonably expected in this location.




