

WHEREAS:

- (1) It appears to the North Wiltshire District Council ("the Council") being the local planning authority for the purposes of Section 87 of the Town and Country Planning Act 1971 ("the Act") in this matter, that there has been a breach of planning control after the end of 1963 on the land or premises ("the land") described in Schedule 1 below.
- (2) The breach of planning control which appears to have taken place consists in the carrying out of development by the making of the material change in the use of the land described in Schedule 2 below, without the grant of planning permission required for that development.
- (3) The Council consider it expedient, having regard to the provisions of the development plan and to all other material considerations, to issue this enforcement notice, in exercise of their powers contained in the said Section 87, for the reasons set out in the ANNEX to this Notice.

NOTICE IS HEREBY GIVEN that the Council require that the steps specified in Schedule 3 below be taken in order to remedy the breach within the period of SIX MONTHS from the date on which this Notice takes effect.

SCHEDULE 1 Land or premises to which this notice relates

Land comprising O.S. parcel 8316, Chelworth Road, Chelworth, Cricklade, Wiltshire shown stipple edged on the attached plan.

SCHEDULE 2 Alleged breach of planning control.

The making of a material change in the use of the land from use for the purpose of agriculture to use for that purpose and in addition, the storage of building materials, sectional buildings, commercial vehicles, motor cars, trailers, van bodies, caravans, machinery and associated parts.

SCHEDULE 3 Steps required to be taken

- (i) To cease the use of the land for storage other than agricultural storage.
- (ii) To remove from the land the said building materials, sectional buildings, commercial vehicles, motor cars, trailers, van bodies, caravans, machinery and associated parts.
