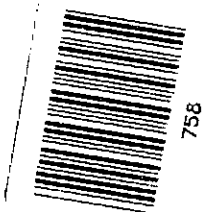

This Notice has been served on you as it appears to the Council that the amenity of part of the district is adversely affected by the condition of your property at Hill Farm, Greenhill. Unless an appeal is made in the manner described below, the Notice will take effect on the date shown and you must then ensure that the required steps are taken within the period or periods specified in the Notice. If you fail to take the steps required by the Notice, within the time specified for compliance (or such period as the Council will allow) you shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 3 on the standard scale currently £1,000.

If you wish to appeal against the Notice, you should make your appeal to the Magistrates Court acting for the petty sessions area in which the land in question is situated. Any appeal must be made before the date when the Notice comes into effect.

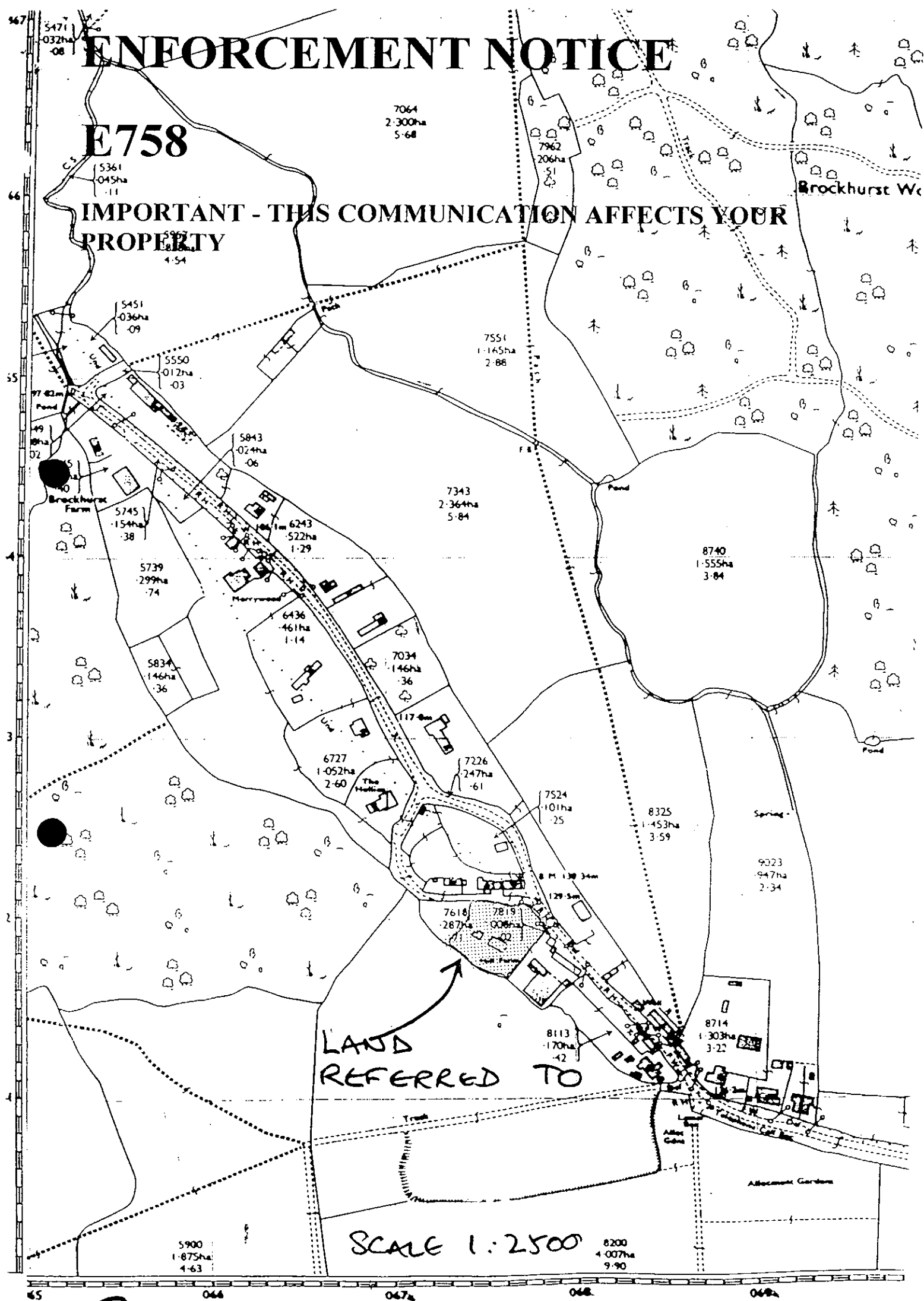

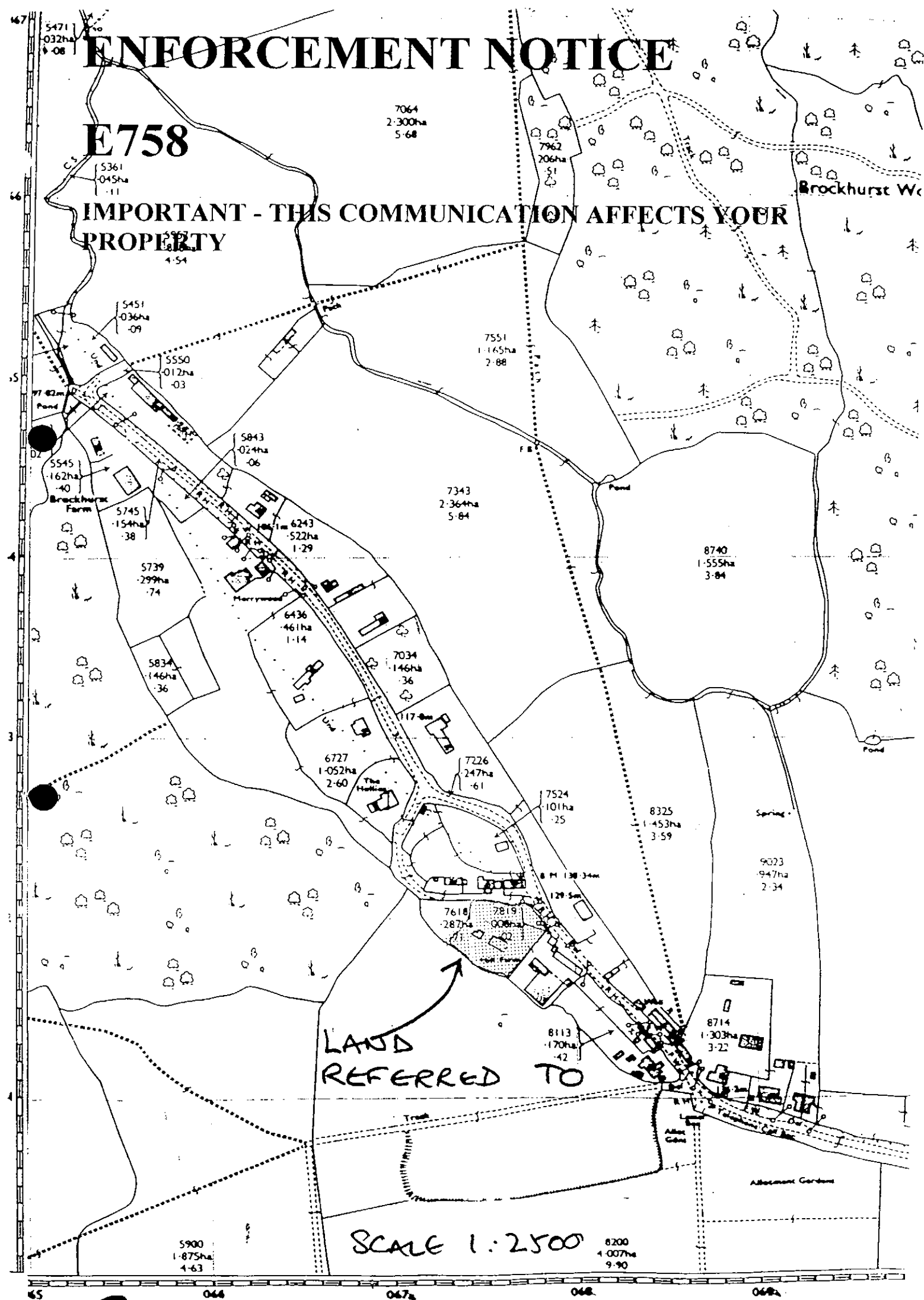
